If the **Contractor** supplies the **Property Owner/Agent** with signs and/or product other than the impound services outlined in this contract, the **Property Owner/Agent** will be held responsible for installation of Tow Away Signs to city, state, or county code, whichever applies. The **Property Owner/Agent** shall also be responsible for reimbursement to the **Contractor** for the cost of materials provided if damaged or stolen, unless weather worn, after the initial sign(s) and/or product(s) are delivered.

If **Property Owner/Agent** decides they no longer need/want towing service, the contract may be cancelled. To request the cancelation of this contract, an explanation in writing must be received within 30 days prior to cancel date.
